



Annual Medicare D Creditable Coverage Notice

To: All Benefits-Eligible Employees

You are receiving this letter because you are eligible for benefits through Capital Region BOCES. It only applies to those medical plan participants who currently are Medicare eligible or will be during 2018.

The law requires us to notify all individuals who are benefits-eligible and also eligible for Medicare, as well as anyone who may have a spouse or dependent who is eligible for Medicare. Receipt of this information does not indicate that you are eligible for Medicare. Rather than risk missing anyone who falls into one of these two groups, we are sending the information to all individuals who are eligible for benefits.

The attached Creditable Coverage notice confirms that the prescription drug benefits provided by the current Empire Prism and NYSHIP Plan plans are richer than the standard benefits offered under Medicare Part D.

If you or a family member are eligible for Medicare and covered by one of the Empire Prism and NYSHIP Plan medical plans offered by Capital Region BOCES, please read the attached notice and keep it in your records as proof of creditable coverage.

Important Notice from Capital Region BOCES About Your Prescription Drug Coverage and Medicare

Please read this notice carefully and keep it where you can find it. This notice has information about your current prescription drug coverage with Capital Region BOCES plan and about your options under Medicare's prescription drug coverage. This information can help you decide whether or not you want to join a Medicare drug plan. If you are considering joining, you should compare your current coverage, including which drugs are covered at what cost, with the coverage and costs of the plans offering Medicare prescription drug coverage in your area. Information about where you can get help to make decisions about your prescription drug coverage is at the end of this notice.

There are two important things you need to know about your current coverage and Medicare's prescription drug coverage:

- 1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare. You can get this coverage if you join a Medicare Prescription Drug Plan or join a Medicare Advantage Plan (like an HMO or PPO) that offers prescription drug coverage. All Medicare drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.**

- 2. Capital Region BOCES has determined that the prescription drug coverage offered by Empire Prism and NYSHIP Plan plan is, on average for all plan participants, expected to pay out as much as standard Medicare prescription drug coverage pays and is therefore considered Creditable Coverage. Because your existing coverage is Creditable Coverage, you can keep this coverage and not pay a higher premium (a penalty) if you later decide to join a Medicare drug plan.**

When Can You Join A Medicare Drug Plan?

You can join a Medicare drug plan when you first become eligible for Medicare and each year from October 15th through December 31st.

However, if you lose your current creditable prescription drug coverage, through no fault of your own, you will also be eligible for a two (2) month Special Enrollment Period (SEP) to join a Medicare drug plan.

What Happens To Your Current Coverage If You Decide to Join A Medicare Drug Plan?

If you decide to join a Medicare drug plan, your current coverage will not be affected. You may keep this coverage if you elect part D. If you do decide to join a Medicare drug plan and drop your current Capital Region BOCES coverage, be aware that you and your dependents may not be able to get this coverage back.

When Will You Pay A Higher Premium (Penalty) To Join A Medicare Drug Plan?

You should also know that if you drop or lose your current coverage with Capital Region BOCES and don't join a Medicare drug plan within 63 continuous days after your current coverage ends, you may pay a higher premium (a penalty) to join a Medicare drug plan later.

If you go 63 continuous days or longer without creditable prescription drug coverage, your monthly premium may go up by at least 1% of the Medicare base beneficiary premium per month for every month that you did not have that coverage. For example, if you go nineteen months without creditable coverage, your premium may consistently be at least 19% higher than the Medicare base beneficiary premium. You may have to pay this higher premium (a penalty) as long as you have Medicare prescription drug coverage. In addition, you may have to wait until the following October to join.

Remember: Keep this Creditable Coverage notice.
